# Kentucky Lottery Corporation <br> NASCAR Powerball Playoff ${ }^{\circledR}$ iLottery Online Promotion 

Statewide iLottery Online Second Chance Promotion
Rules \& Regulations

## GENERAL:

1. The Kentucky Lottery Corporation (KLC) plans to conduct a "NASCAR Powerball Playoff ${ }^{\circledR}$ iLottery Online promotion with Powerball ${ }^{\circledR}$ played online under the provisions provided in these rules and regulations.
2. The promotional period will take place from 12:00:00 AM ET on Monday, May 6, 2024, and 11:59:59 PM ET on Sunday, June 16, 2024. The promotion drawing will be held on or about Thursday, June 20, 2024.
3. Players are eligible to receive one (1) entry each day of the promotion when the player has purchased at least three dollars (\$3.00) in Powerball ${ }^{\circledR}$ (with Power Play ${ }^{\circledR}$ ) online. The minimum purchase necessary to qualify for entry is a total of three dollars (\$3.00) within a calendar day from 12:00:00 AM - 11:59:59 PM EST. Players with a qualifying Powerball ${ }^{\circledR}$ purchase of at least three dollars ( $\$ 3.00$ ) will automatically be entered into the promotion.

- A maximum of forty-one (41) entries, one per day, are possible during this promotion.

4. The KLC will draw one (1) Tier 1 prize package and twelve (12) Tier 2 prizes from all eligible online entries. There will be a total of four (4) prize drawings, two (2) from retail and two (2) from iLottery. A player may only win one (1) of the four (4) prize drawings. Each Winner will be awarded a Tier 1 (NASCAR) or Tier 2 (KLC) Prize Package. Prize Details are listed below:

- Tier 1 - One (1) winner will be selected from eligible online entries, with three (3) alternates. The winner of this drawing will receive the Tier 1 NASCAR Powerball Playoff Prize Package described below.

- Tier 2 - Twelve (12) winners will be selected from eligible online entries, with twenty (20) alternates. The winners from this drawing will receive the KLC Tier 2 Prize package described below.
- Tier 2 Prize details:
- Twelve (12) Tier 2 prizes valued at approximately $\$ 200$ will be awarded:

1. $\$ 100$ worth of Bonus Bucks
2. $\$ 100$ worth of Powerball Coupons
3. The twelve (12) Tier 2 KLC online prize winners will also be entered into a drawing for a chance to win the NASCAR Playoff Grand Prize Experience provided by MUSL, or a third-party under contract with MUSL to fulfill elements of the trip prize. Each participating state lottery will provide their eligible entrants to MUSL to be entered into the national pool for the first of five NASCAR Powerball Playoff drawings. Sixteen (16) semi-finalists will be drawn from the national pool by MUSL, with no more than one semi-finalist per lottery advancing. The sixteen national semi-finalists will compete in a series of elimination drawings for a chance to go to the NASCAR Cup Series Championship ${ }^{\text {TM }}$ race in Phoenix (the "NASCAR Powerball Playoff Prize Package" or "NASCAR Powerball Playoff Prize Experience"). - Four (4) finalists (the "NASCAR Powerball Playoff Prize Finalists") will be selected from all participating state lotteries' eligible semi-finalist winners (there will be four (4) total finalists).
- Each of the four (4) NASCAR Powerball Playoff Prize Finalists will be awarded the NASCAR Powerball Playoff Prize Package (Trip Prize) see sections 5 and 6 below for specific prize details.
- The four (4) NASCAR Powerball Playoff Prize finalists will also be entered into a drawing, conducted by MUSL, as part of the NASCAR Cup Series Championship live at Phoenix Raceway for a chance to win the $\$ 1,000,000.00$ Grand Prize (the "NASCAR Powerball Playoff Grand Prize").

8. Two (2) drawings will be conducted, and three (3) alternates will be selected for Tier 1 and twenty (20) alternates will be selected for Tier 2 as noted in Item 4.
9. This promotion is only available at play.kylottery.com. Tickets purchased at retail are eligible for a separate promotion; see retail rules for "NASCAR Powerball Playoff®" https://www.kylottery.com/apps/funclub/terms.html.
10. Player's funding transactions are subject to a player's Fun Club account balance and deposit limits.
11. All deposited funds must be spent on KLC games purchased via the Internet and cannot be withdrawn.
12. Qualifying plays must be completed by 11:59:59 PM ET on Sunday, June 16, 2024, to be eligible for the drawing on or about Thursday, June 20, 2024.
13. Failure to provide accurate information could disqualify a player whose entry is selected as a winner for this promotion. A player shall be considered ineligible if the KLC determines that a player does not meet all player eligibility requirements or provided false information.
14. The KLC assumes no responsibility for incorrect information provided by a player on the Fun Club registration form. After completing the registration, a player is responsible for updating account information as needed by logging in and going to his or her account profile page.
15. A player may have no more than one (1) account. A player is not permitted to create additional accounts if his or her email or other relevant information changes. The player may log in with his or her existing account credentials and make any desired changes at any time.

## ELIGIBILITY:

16. To be eligible for the promotion, players must first register for a Fun Club account at kylottery.com. Players must be in compliance with all requirements of the Fun Club Terms of Use, including requirements for registering for or updating an existing account in order to enter a promotion. Fun Club accounts that are Opted Out or Manually Disabled are ineligible to enter or to win.
17. To play internet-based lottery games, players must be at least 18 years old, have a valid US address, be physically located within the boundaries of Kentucky, and otherwise be in compliance with the iLottery Terms of Use.
18. No one otherwise prohibited by KRS Chapter 154A from playing KLC games are eligible to participate in this promotion or win any prize.

## ODDS:

19. Odds of being selected as a winner in the promotion will depend on the number of eligible entries that take place during the promotional period.

## SUBMITTING ENTRIES:

20. Players with a qualifying play during the promotional period will be automatically entered into the promotion.
21. Players will receive one (1) entry for each qualifying play as described in Item 4.
22. By playing qualifying Powerball ${ }^{\circledR}$ (with Power Play ${ }^{\circledR}$ ) game(s) during the promotional period, the players agree to these rules and regulations, the rules and regulations for the iLottery purchase of Online and Instant Games, and the Fun Club and iLottery Terms of Use, and the Online and Instant Play Game rules and regulations for the qualify game(s).
23. Players entering this promotion and the retail "NASCAR Powerball Playoff®" promotion can win only one (1) KLC Prize. If a player has been chosen as the winner of the retail "NASCAR Powerball Playoff ${ }^{\circledR \prime \prime}$ promotion and the player is subsequently also selected as the winner of this online promotion, the player will be disqualified from this online promotion and the first alternate will be selected as the winner.

## KLC PRIZE DRAWING:

24. All drawing management services associated with this promotion for the Tier 1 and Tier 2 winners will be conducted by the KLC. The NASCAR Powerball Playoff ${ }^{\circledR}$ Drawings will be conducted by MUSL according to MUSL specific terms and procedures in MUSL's sole discretion.
25. At the conclusion of the promotional period, the KLC will run an IGT system-generated report utilizing the criteria set forth for this promotion.
26. The prize winner drawings will be conducted according to KLC drawing procedures.
27. During the drawing, alternates will be sel13ected as noted in Item 8. If there is an insufficient number of entries, the KLC may reduce the number of alternates selected in its sole discretion. Alternates are not prize winners, but are selected if a winner is disqualified, unable to claim the prize, or declines to accept. Once an eligible alternate is moved up to become a prize winner, his or her alternate status in the drawing will be voided.

## MUSL SEMI-FINALIST DRAWINGS:

28. When MUSL draws the sixteen (16) semi-finalists from the national pool, no more than one (1) semi-finalist per lottery will advance. This means there will be a total of sixteen (16) semifinalists from the sixteen (16) different participating lotteries entered into the NASCAR Powerball Playoff drawings.
29. MUSL will conduct a draw on August 13, 2024, at MUSL HQ to select sixteen (16) semi-finalists. Semi-finalists will be notified. A public announcement of the sixteen semi-finalists will be made September 1, 2024 during the Cook Out Southern 500 at Darlington Raceway in Darlington, SC.
30. MUSL will conduct a second draw on September 12, 2024, at MUSL HQ to select twelve (12) semi-finalists from the pool of sixteen (16). Remaining contestants will be notified. The four (4) semi-finalists not selected to move to the next round of drawings will be awarded a $\$ 2,500.00$ prize. A public announcement of the final twelve (12) semi-finalists will be made September 21, 2024, during the Bass Pro Shops Night Race in Bristol, TN.
31. MUSL will conduct a third draw on October 3, 2024, at MUSL HQ to select eight (8) semi-finalists from the pool of twelve (12). Remaining contestants will be notified. The four (4) semi-finalists not selected to move to the next round of drawings will be awarded a $\$ 5,000.00$ prize. A public announcement of the remaining eight (8) semi-finalists will be made October 8, 2024, during the Bank of America Roval ${ }^{\text {TM }} 400$ in Concord, North Carolina.

## MUSL FINALIST DRAWING:

32. MUSL will conduct a fourth draw on October 17, 2024, at MUSL HQ to select four (4) NASCAR Powerball Playoff Finalists. Travel arrangements will be made for the four (4) finalists and their one (1) guest to attend the final draw in Phoenix for the $\$ 1$ million NASCAR Powerball Playoff Grand Prize. The four (4) semifinalists not selected to advance to the final grand prize drawing will be awarded a $\$ 7,500.00$ prize. A public announcement about the four (4) finalists will be made Sunday, November 3, 2024, at the Xfinity 500 at Martinsville Speedway in Martinsville, VA.

## MUSL GRAND PRIZE DRAWING:

33. MUSL will conduct a fifth and final draw on November 10, 2024, to select one (1) NASCAR Powerball Playoff Finalist as the winner of the NASCAR Powerball Playoff Grand Prize of One Million Dollars (\$1 million) during the NASCAR Cup Series Championship Race live at Phoenix

Raceway in Avondale, AZ. The three (3) finalists not selected as the Grand Prize Winner will be awarded a $\$ 10,000$ prize.

## KLC PRIZE PACKAGE FULFILLMENT:

34. A member of the KLC's Marketing Department will attempt to contact all Semi-finalist prize winners using the phone and email contact information provided in the winner's Fun Club profile at the time of the drawing. The KLC may take the following steps to contact each winner:

- Email the winner's email address provided on the profile. The KLC may also provide a courtesy call to both the primary and secondary phone number provided on the profile. Continued attempts to contact by phone will not be made. The email contact is the official notice of the win starting the claim period set forth in item 38 below.

35. If the KLC determines that dialogue with the winner has not been established by phone, email, or other means acceptable to the KLC, within three (3) business days of KLC's initial contact attempt, the winner will be disqualified, and the prize will be awarded to the first eligible alternate selected.
36. A winner must claim their prize within three (3) business of the initial contact date the KLC Marketing Department made initial contact with the winner. The person whose name is on the entry must be the person who claims the prize. Winner must provide a valid government issued photograph identification, such as a driver's license, or other form of photograph identification acceptable to the KLC, and a completed Promotion Claim Form that they will receive from the KLC Marketing Department. The prize will be awarded only after the KLC receives the prize winner's accurate and complete Promotion Claim Form and required ID. If all required information is not received within three (3) business days, the prize will be forfeited and awarded to the first alternate selected in the drawing. This process will continue until a winner has claimed the prize or all alternates have been exhausted, whichever comes first. If all alternates have been exhausted the prize will not be awarded. All required information may be provided to the KLC by fax, email, U.S. Mail, or hand-delivery to the KLC Corporate Office. The KLC in its discretion may also provide a digital claim process with a verified electronic signature, such as Docusign. If sent by fax or email, a member of the KLC's Marketing Department will provide a fax number or email address upon winner's request. NOTE: When sending personally identifiable information, such as a Social Security Number, to the KLC by email, winners should use a secure or encrypted email. Information about how to use a secure or encrypted email may be requested from the Marketing Department.
37. If, prior to the expiration of the three (3) business days referenced in the preceding paragraphs, a winner declines to accept and claim the prize by notifying a member of the ilottery Department in writing via the winner's e-mail, the prize may be forfeited immediately upon receipt of the written notification and the first eligible alternate declared the winner.
38. The KLC or its designee will withhold federal, state and all applicable taxes, according to federal and state withholding requirements for any prizes won. Any taxes above the standard formulas
are the responsibility of the winner. Prizes may be subject to set off of certain debts as required by law.
39. The prize is not transferable or assignable.
40. Fulfillment of the prize will be handled by the KLC and MUSL. If a KLC semi-finalist is drawn as one of the four finalists, winner and guest are subject to the NASCAR Powerball Playoff Prize Experience Trip Prize Terms and Conditions.
41. The KLC will provide the names of the twelve (12) eligible KLC semi-finalist winners to MUSL to conduct the NASCAR Powerball Playoff ${ }^{\circledR}$ Grand Prize Drawing. If a KLC semi-finalist is drawn as one of the NASCAR Powerball Playoff ${ }^{\circledR}$ Grand Prize finalists, they will be entered by MUSL into the "NASCAR Powerball Playoff ${ }^{\oplus}$ Grand Prize Experience. These drawings are subject to the Prize Description and Prize Terms and Conditions, and all drawing procedures will be conducted according to MUSL in their sole discretion. All NASCAR Powerball Playoff® Semi-finalist Drawings and NASCAR Powerball Playoff ${ }^{\oplus}$ Grand Prize Drawing winners agree to be bound by the rules, regulations, and terms and conditions of MUSL and its partners.

## FULFILLMENT OF BONUS BUCKS

42. In order to play internet-based games, the player must provide a valid U.S. address, be physically located within the boundaries of Kentucky at the time of purchase, and subject to age and identity verification. If the winner does not have a valid U.S. address, is not physically located within the boundaries of Kentucky at the time of purchase, or the winner's identity cannot be verified, the winner will not be able to purchase tickets online. The winner must notify the KLC once the account has been created and confirmed. Bonus Bucks are applied directly to a player's Fun Club account and must be spent on KLC games purchased via the Internet; Bonus Bucks cannot be withdrawn or redeemed for a retail purchase. Bonus Bucks will appear in the player's Fun Club account within 14 business days of creating the account.

## NASCAR POWERBALL PLAYOFF PRIZE EXPERIENCE TRIP PRIZE TERMS AND CONDITIONS

43. The NASCAR Powerball Playoff Prize Finalists and Guest are subject to and agree to be bound by the MUSL NASCAR Powerball Playoff Promotion (2024) Trip Prize Terms and Conditions. To access the terms and conditions please visit the Prize Terms and Conditions Page.

## ADDITIONAL CONDITIONS:

44. All winners are subject to validation by the KLC and may be disqualified if eligibility requirements are not met. 48. The KLC is not responsible for any rules, regulations or restrictions imposed by its promotional partners. The KLC is not responsible for and has no obligation regarding the condition, quality, defects or other attributes of the prizes awarded during a promotion and expressly disclaims all warranties, expressed or implied, including, but not limited to, all implied warranties of merchantability and fitness for a particular purpose.
49. The KLC is not responsible for any issues with prize fulfillment caused by Released Parties or their representatives or agents. Nor is the KLC responsible for circumstances including, but not limited to event cancellation, venue or activity substitutions, or modifications to any other prize elements that are out of the KLC's control.
50. The KLC in its discretion reserves the right to change or extend any of the dates set out in these rules. The KLC reserves the right, in its sole discretion, to modify, suspend, postpone or cancel, with or without notice, any portion of this promotion, including the drawing, at any time and for any reason, including the award of any prize, with the approval of the KLC's President \& CEO or appropriate designee from the Executive Management group.
51. The KLC reserves the right to substitute prizes of equivalent value.
52. In computing any period of time under these rules, the day of the designated act or event is not to be included; the last day of the period so computed is to be included. The term "business day" means a day that the KLC Corporate Office is actually open for business (holidays, weekends and other days the KLC is closed are excluded), and such day is from 8:00 AM to 5:00 PM ET.
53. In the event of any circumstances or interpretation of any matter in these rules, whether contemplated or not contemplated, the decision of the President \& CEO or appropriate designee from the KLC's Executive Management Group, will be final.
54. This promotion is void where prohibited by law.
